Your domain purchase renewals will be coming through soon, either through an email prompt, our telephone team or invoice.

Automatic relicensing ensures you never lose a top level domain to your competitors.

Please respond **within 14 days** if you would like to be on automatic or manual licensing. If we don't hear from you, we simply leave your existing preference in place.
